





THIS SHOW IS OPEN TO ALL

Vicious dogs are not eligible and should not be brought to the show

Exhibitors are held responsible for any damage done by their dog during the exhibition.

Admission to the show is free Children under the age of 11 are the responsibility of and must be accompanied at all times, by a Parent or Guardian, even when in the ring

- 1 The Show will open at 7 30 a m
- 2 Exhibits will be received until 12 noon and after which no dogs may be received except under exceptional and unforeseen circumstances and by any special permission of the Show Management. Exhibitors are reminded that it is their responsibility to ensure that exhibits are available for judging when required.
- Breed Judging will commence at 9.00 a.m. promptly unless otherwise advertised in the dog press, or in the probable order of judaina.
- Exhibits may be removed from the Show after their judging has been completed. Exhibits may not be removed any earlier unless by written order of the Veterinary Surgeon, Veterinary Practitioner or of the Show Management and then only in very exceptional and unforeseen circumstances which must be reported to the Kennel Club. The Show will close half an hour after all judging has been completed, by which time dogs must be removed.
- Breeds with Challenge Certificates on offer first entry with each dog: £30.00. Breeds without Challenge Certificates, A.V. Not Separately Classified, Veteran and Champion Stakes (if first entry): £15.00. Each subsequent entry with the same dog £5.00. JHA & YKC Classes £5.00. Not For Competition £10. KC Breeders Competition £15. There is no separate benching fee. All entry fees and other charges quoted in the schedule and on the entry form are inclusive of VAT where this tax is applicable. Provided it is registered at the Kennel Club, an exhibit may be entered "Not for Competition". Details of each dog so entered must be recorded on the entry form. No dog other than an exhibit will be allowed within the precincts of the Show during its continuance, except Spectator Dogs over 4 months of age where the entry fee is £5.00. Entry fees once made are not returnable and cannot be refunded. Cheques to be made payable to "Windsor Championship

Dog Show". All payments must be in sterling and drawn on a UK bank. Entries may be made on-line at www.highampress.co.uk

- 6 Prize money will only be paid in Stakes Classes as listed.
- The Committee reserves to itself the right to refuse entries
- Puppies under six calendar months of age on the first day of the Show are not eligible for exhibition.
- The mating of bitches within the precincts of the Show is forbidden.
- Best Puppy In Show: Where a Best Puppy in Show competition is scheduled the Best Puppy in Show is a puppy which has competed and has been declared Best Puppy in Breed. Best Any Variety Not Separately Classified Puppy or Best Any Variety Imported Breed Register Puppy. A puppy is a dog of six and not exceeding twelve calendar months of age on the first day of the Show. Where the Best of Breed, Best in Group or Best in Show is a puppy it may, at the discretion of the judge, be awarded Best Puppy in Breed, Best in Group and Best Puppy in Show respectively. Similarly, if the Reserve Best of Breed, Reserve Best of Group or Reserve Best in Show is a puppy which has only been beaten by an adult dog it may, at the discretion of the judge, be Best Puppy in Breed, Best Puppy in Group and Best Puppy in Show respectively. Consequently, selection of Best Puppy in Breed, Best in Group and Best Puppy in Show must follow the selection of Best of Breed and Best in Show respectively.
 - (a) Shows Judged on the Group System.
 - (1) Best Puppy in Breed.
 - A Best Puppy may be declared in each breed from puppies entered in the breed classes.
 - A Best Puppy may be declared from the Any Variety Not Separately classified class(es).
 - A Best Puppy may be declared from the Any Variety Imported Breed Register class(es).
 - (2) Best Puppy in Group. Best Puppy in Group and subsequent Puppy Group placings must be selected from:
 - Best puppy in group and subsequent puppy group placings must be selected from:-

 - a) Those puppies declared Best Puppy in Breed
 b) The puppy declared Best Puppy from the Any Variety Not Separately Classified classes in each group
 - c) The puppy declared Best Puppy from the Any Variety Imported Breed Register classes in each group
 - (3) Best Puppy in Show must be selected from the Best Puppy in Group winners.
- Best in Show: The dog declared Best in Show is a dog which has competed and has been declared Best of Breed. Best Any Variety Not Separately Classified or Best Any Variety Imported Breed Register.
 - a. Shows Judged on the Group System
 - (1) Best of Breed

Where a breed is separately classified a Best of Breed may be declared but only from those dogs which have received a first prize in a breed class at the show. Where separate classes are provided for each sex of a breed a Best of each Sex must be declared.

NOTE: The Best of Breed/Best Any Variety Not Separately Classified/Best Any Variety Imported Breed Register award relevant to a Category 3 Breed will not be confirmed until the dog has passed an examination by the General and Group Championship Show Veterinary Surgeon.

(2) Best of Group

Best of Group and subsequent Group placings must be selected from:-

- (a) The Best of Breed winners in each group
 (b) The dog declared Best from Any Variety Not Separately Classified classes in each Group or on each day.
 (c) The dog declared Best from Any Variety Imported Breed Register class or classes in each Group or on each day. NOTE: The dog declared Best of Breed/Best Any Variety Not Separately Classified/ Best Any Variety Imported Breed Register from a breed designated by the Kennel Club as a Category 3 Breed is not eligible to compete in the Group competition unless it has passed an examination by the Show's Veterinary Surgeon. If the dog fails to pass the examination it is ineligible to compete in the relevant Group.

(3) Rest in Show

Best in Show must be selected from the Best of Group winners. Reserve Best in Show must be selected from the remaining Group winners following the selection of Best in Show

- 12 Exhibits will not be admitted to Group or Best in Show competition after a period of ten minutes has elapsed since the announcement that exhibits are required for judging, unless they have been unavoidably delayed by previous judging not being completed on time, and then only with the special permission of the Show Management.
- 13 Exhibitors must not pick up dogs by their tails and leads when lifting them <u>nor handle a dog in a manner which causes its feet not to touch the ground when on the move.</u> This is not acceptable. Exhibitors should note that such practice would constitute harsh handling and reports of such practice will be referred to the Committee under Kennel Club Show Regulation F11.
- 14 All exhibitors must be familiar with Kennel Club Regulation F (Annex B): Regulations for the Preparation of Dogs for Exhibition.
- 15 All dogs resident outside the UK must be issued with a Kennel Club Authority to Compete number before entry to the show can be made. All overseas entries without an Authority to Compete number will be returned to the exhibitor/competitor.
- 6 DOGS MUST NOT BE LEFT UNATTENDED IN VEHICLES.

DOGS IN VEHICLES ON HOT DAYS: Anyone whose dog is entered at a Kennel Club licensed event should take all reasonable steps to ensure the needs of their dog(s) are met, and should not put a dog's health and welfare at risk by any action, default, omission or otherwise. Breach of the Kennel Club Regulations in this respect may be referred to the Board for disciplinary action under Kennel Club Rules and Regulations.

- When travelling to a show please take a moment to consider whether the route to the show is on a busy holiday
 route, and leave earlier to avoid increased time in traffic jams.
- If your vehicle is not air-conditioned seriously consider whether travelling to the show is a good idea at all.
- The vehicle should be as fully ventilated as possible, and plenty of stops should be taken, with lots of water available
 to drink
- Ensure your dog is not sitting in full sunlight. There should be plenty of free flowing air around the dog.
- When at the show, never leave your dog in the vehicle.
- Keep the dog in the shade take your own shade, for example a large umbrella and always have plenty of water available to drink so your dog stavs well hydrated.
- · Avoid your dog taking part in unnecessary exertion, or from standing in exposed sunlight for extended lengths of time.

Remember, if you feel hot your dog is very likely to feel much hotter and dehydrated, and this could lead to dire results. Please look after your dog's welfare.

WARNING: IF YOUR DOG IS FOUND TO BE AT RISK, FORCIBLE ENTRY TO YOUR VEHICLE MAY BE NECESSARY WITHOUT LIABILITY FOR ANY DAMAGE CAUSED.

- 17 Anyone whose dog is entered at a Kennel Club licensed event should take all reasonable steps to ensure the needs of their dog(s) are met, and should not put a dog's health and welfare at risk by any action, default, omission or otherwise. Breach of the Kennel Club Regulations in this respect may be referred to the Board for disciplinary action under Kennel Club Rules and Regulations. The use of pinch collars, electronic shock collars, or prong collars, is not permitted at any show licensed by the Kennel Club. This shall apply at the venue or within the precincts of the show.
- 18 Not For Competition entries will be accepted. Details of each dog so entered must be recorded on the entry form and must be Kennel Club Registered.
- 19 No modifications will be made to this Schedule except by permission of the Board of The Kennel Club, which will be followed by advertisement in the Canine Press wherever possible.
- 20 The Show will be held under Kennel Club Limited Rules and Show Regulations. Every exhibitor making an entry or entries at this Show shall be deemed to have agreed to abide by the Kennel Club Limited Rules and Show Regulations. It is on this understanding only that entries will be accepted.
- 21 Entries must be made on or before Wednesday 11th May, 2022 (Postmark) upon forms enclosed for that purpose. However entries may be made online up to midday on Monday 6th June 2022 at www.highampress.co.uk. If acknowledgement of postal entries is required, a stamped addressed postard must be enclosed. In your own interest please use FIRST CLASS mail. The only proof of posting entries acceptable to The Kennel Club is the certificate of posting issued free by the Post Office, Recorded Delivery or Registered Post. If an envelope containing entries bears more than one postmark, the latest date will be considered to be the date of posting. Entries delivered by hand to the Secretary's address, either by an exhibitor or his/her agent, must be handed in on or before the date stated for the closing of entries by postmark, i.e. before midnight on Wednesday 11th May 2022.
- 22 Exhibitors showing dogs are not permitted to hold conversations with the Judges during the competition and any exhibitor who persists in addressing the Judge after being requested not to do so by the Ring Steward, the Judge, or any member of the Committee, may be disqualified and any prize awarded to his or her dogs be forfeited. No person, other than the exhibitors (Officials excepted) will be allowed in the ring during the judging of classes or Specials.
- 23 A special place will be provided for the preparation of dogs and no exhibitor will be permitted to clean or prepare dogs anywhere in the Show except in the place provided.
- 24 The Committee is empowered to exclude or to remove any dog which is not in a fit state for exhibition, from disease, natural or other causes. If such exclusion takes place either before or after the dog is judged, the entrance fee will be forfeited.
- 25 All exhibits must be accompanied. The Committee cannot undertake to accept or despatch unaccompanied dogs.
- 26 All dogs must be removed from their benches within 30 minutes of the completion of Group judging on the first three days, and after the Best in Show judging on the final day.
- 27 Should any of the judges be prevented from fulfilling their engagement the Show Committee reserves the right of appointing a substitute. Exhibitors are at liberty to withdraw from competition, but no entrance fee can be returned.
- 28 All Rules and Regulations and Instructions of the nature of rules and regulations printed for convenience in other parts of this Schedule shall be deemed to be Regulations of the Committee and shall have the same effect as if they formed part of these Regulations. Should any question arise not provided for in these Regulations the decision of the Committee shall be final, subject to appeal to The Kennel Club.
- 29 Exhibitors and spectators are reminded that just as Windsor Dog Show Society has a responsibility to ensure the health and safety of all those attending their event, all those present have a duty and responsibility for their own safety. They are therefore

expected to take the greatest care to avoid duy ropes, uneven surfaces and other hazards, which are inevitable and integral elements of a dog show. Those bringing and using portable items of equipment such as folding chairs, trollevs, cages and grooming tables also have a responsibility to ensure that their tools, equipment and collapsible furniture is used and erected safely and does not constitute a hazard to others. Exhibitors are also reminded that they should wear appropriate clothing and footwear for the prevailing conditions on the site. Exhibitors show at their own risk if conditions are not ideal

- The Committee will not be in any way responsible for any claim for injury or compensation occasioned by or arising out of the holding of the Show, or by reason of the act or default of any person in attendance or present thereat.
- Photography and Video Rights: The Organisers would like to bring the regulation on photography and filming to the attention of exhibitors, trade stands, press and visitors.

It is a condition of all those attending the event that no filming or other form of recording may be taken or made at the venue without express written permission of the organisers. The taking of photographs in the show venue for sale or reward is strictly prohibited except with the written permission of the Organisers. Press accredited photographers are provided with permission to take photographs ONLY for use in newspapers, magazines and internet sites—this is for news purposes only There is no objection to the general public taking photographs of general views of the show, provided that these are for private use. Specific dogs may be photographed only with the approval of the exhibitor. No photography or filming is permitted in breed judging rings whilst judging is actually taking place. However, judges may allow it to happen at the end of classes or after the Challenge Certificate is awarded. Filming and flash photography is allowed from outside the rings at all times unless the operation of the camera is actually affecting exhibits. However, if a powerful flash unit is used or it is clear that exhibits are being affected, a ring steward or the judge is empowered to stop the person concerned.

DEFINITIONS OF CLASSES (As provided in Kennel Club Definitions of Classes)

PUPPIES LINDER SIX CALENDAR MONTHS OF AGE ON THE FIRST DAY OF THE SHOW ARE NOT FLIGIBLE FOR EXHIBITION. ie. BORN AFTER 30th DECEMBER 2021

In the following Definitions, a Challenge Certificate includes any Show award that counts towards the title of Champion under the rules of any governing body recognised by The Kennel Club.

Wins at Championship Shows in breed classes where Challenge Certificates are not on offer shall be counted as wins at Open Shows

In the case of a dog owned in partnership and entered in Members' Classes or competing for Members' Specials, each partner must, at the time of entry, be a member of the Society.

In estimating the number of awards won, all wins up to and including the seventh day before the closing of Postal entries shall be counted when entering for any class. Up to midnight of Wednesday 4th May 2022.

Wins in Variety Classes do not count for entry in Breed Classes, but when entering for Variety Classes wins in both Breed and Variety Classes must be counted. A First Prize does not include a Special Prize of whatever value.

If an exhibitor reports before the judging of a class or classes that a dog has been entered which is ineligible, the exhibitor may choose one of the following options:

(1) Withdrawal

The dog may be withdrawn from competition subject to the conditions of Regulations F.(1).19.

(2) Transfer

- (a) If a dog is ineligible for a class or classes as regards its breed, colour, sex, weight or height the Show Secretary shall transfer it to the equivalent class or classes for the correct breed, colour, sex, weight or height or, in the event of there being no equivalent class, Minor Puppy and Puppy excepted to the Open class for the correct breed, colour, sex, weight
- (b) For an exhibit entered incorrectly in a Minor Puppy class, Puppy class or Junior class, which is over age but under 12 calendar months of age. 18 calendar months of age or 24 calendar months of age respectively, the Show Secretary shall transfer the exhibit to the Puppy class, Junior class or Yearling class respectively for the correct breed, colour, sex, weight or height and in the event of there being no Puppy, Junior or Yearling class to the Open class for the correct breed, colour, sex, weight or height.
- (c) For any reason other than the above, the Show Secretary shall transfer it to the Open class for the correct breed, colour, sex, weight or height.
- (d) If an exhibit arrives late and misses a class, even if it is the only class in which the dog is entered, the dog may not be transferred to any other class.

MINOR PUPPY - For dogs of six and not exceeding nine calendar months of age on the first day of the Show.

PUPPY - For dogs of six and not exceeding twelve calendar months of age on the first day of the Show.

JUNIOR - For dogs of six and not exceeding eighteen calendar months of age on the first day of the Show.

YEARLING - For dogs of twelve and not exceeding twenty four calendar months of age on the first day of the Show.

- NOVICE—For dogs which have not won a Challenge Certificate/CACIB/CAC/Green Star or three or more First Prizes at Open and Championship Shows (Minor Puppy, Special Minor Puppy, Puppy and Special Puppy Classes excepted, whether restricted or not).
- GRADUATE For dogs which have not won a Challenge Certificate/CACIB/CAC/Green Star or four or more First Prizes at Championship Shows in Graduate, Post Graduate, Minor Limit, Mid Limit, Limit and Open Classes, whether restricted or not, where Challenge Certificates were offered for the breed.
- POST GRADUATE-For dogs which have not won a Challenge Certificate/CACIB/CAC/Green Star or five or more First Prizes at Championship Shows in Post Graduate, Minor Limit, Mid Limit, Limit and Open Classes, whether restricted or not, where Challenge Certificates were offered for the breed.
- MID LIMIT-For dogs which have not become Show Champions under Kennel Club Regulations or under the rules of any governing body recognised by the Kennel Club or won 3 or more CAC/CACIB/Green Stars or won five or more First Prizes in all at Championship Shows in Mid Limit, Limit or Open Classes, confined to the breed, whether restricted or not, at shows where Challenge Certificates were offered for the Breed.
- LIMIT-For dogs which have not become Show Champions under Kennel Club Regulations or under the rules of any governing body recognised by the Kennel Club or won 3 or more CAC/CACIB/Green Stars or won seven or more First

Prizes in all, at Championship Shows in Limit or Open Classes, confined to the Breed, whether restricted or not, at Shows where Challenge Certificates were offered for the Breed.

OPEN—For all dogs of the breeds and varieties for which a class is provided and eligible for entry at the Show.

VETERAN—For dogs of not less than seven years of age on the first day of the Show. Best Veteran in Show to be judged from breed classes only.

CHAMPION—For dogs which have been confirmed a Champion, Show Champion or Field Trial Champion. Champion classes may not be scheduled for individual breeds or varieties of breeds.

BRACE—For two exhibits (either sex or mixed) of one breed belonging to the same exhibitor, each exhibit having been entered in some class other than Brace or Team.

IMPORTED BREED REGISTER—For breeds confined to the Imported Breeds Register and only when an Interim Breed Standard has been published by the Kennel Club. Such breeds may be exhibited in this class only, with the winning dog being eliable for Best in Group/Best Puppy in Group or Best in Show/Best Puppy in Show as relevant.

ANY VARIETY NOT SEPARATELY CLASSIFIED—For breeds of dog for which no separate breed classes are scheduled.

YKC STAKES—Only dogs of six (6) calendar months of age and over on the day of competition are eligible for entry into a YKC qualifying stakes class. Dogs must be on the Kennel Club Breed Register to compete in a YKC stakes competition. The first placed member only in each dog group at the qualifying show will qualify for Crufts. A rosette will be awarded. If a member is disqualified, the qualification does not roll down to the next placing. All pedigree dogs are eligible to take part provided the dog is registered on the Kennel Club Breed Register. The dog must be registered a) solely or jointly in the member's name or b) in the name of a close member of the family (i.e. a group of people related by blood or by marriage) and under these circumstances the dog must be resident at the YKC member's address. No substitute handlers are permitted — the dog must be handled by the registered YKC member. Members are not permitted to allow another individual to show their dog at the qualifier on their behalf if they are not able to attend the class, unless agreed by the YKC Office prior to the show. Members must be aged 6 - 24 years (members 6 years and up to, but not including 25th birthday). Please note that membership of the YKC terminates on a member's 25th birthday. Therefore if a member is aged 25 years or over by the first day of Crufts they will be unable to compete in any YKC class. Please keep this in mind when entering qualifiers throughout the competition, If you enter a Crufts qualifier and you have not previously paid your membership fee then any award will be forfeited Therefore it is important to renew and maintain YKC membership as current if you wish to participate in YKC competitions.

SPECIAL OPEN-Similar to Open Class except that it is restricted as to weight, height, colour, etc.

SPECIAL BEGINNERS—For owner, handler or exhibit never having won a Challenge Certificate.

SPECIAL OPEN WORKING—For Beagles which have hunted with a recognised pack, or hold a Working Certificate recognised by the Kennel Club from a registered Beagle Society, or hunted with the Beagle Club Working Section, three or more times during the current season.

SPECIAL OPEN RACING OR LURE COURSING (Greyhounds or Whippets only)—For Kennel Club Registered Whippets that have either (a) during the year ending at the closing date for Crufts entries, won a race at a club affiliated to the Whippet Club Racing Association or (b) during the year ending at the closing date for Crufts entries, competed at a recognised Lure Coursing club and achieved a creditable score/level of performance sufficient to demonstrate natural ability; and for Kennel Club registered Greyhounds that must also be registered with the GBGB or the NCC.

SPECIAL OPEN LONG COATED—For Long-coated German Shepherd Dogs.

KENNEL CLUB BREEDERS' COMPETITION—Each team will consist of a minimum of three and maximum of four dogs of one breed, all bred by the same breeder or breeding partnership. The breeder enters the class and then arranges which dogs are exhibited on the day of the show (from those dogs duly entered for exhibition in another class at this show). Please clearly state the name and affix of the registered breeder(s). Entries will not be taken on the day of the show. Teams will be awarded points/prize money in the KC Breeders' Competition as follows: Points 1st; 30; 2nd 15; 3rd 10; 4th 5. Prize Money 1st Non ABS Prize Fund £25, ABS Prize Fund £25. Please note that Assured Breeders will be credited with a higher prize value. These points will be recorded in the Kennel Club Breeders Competition record book through the year. The minimum qualification for the Crufts final will be 50 points, with a maximum of 40 finalists including the winning teams from the European and World Dog Shows' breeders competition. Our Dogs will collate the points and publish a leader board through the year.

KENNEL CLUB GOOD CITIZEN DOG SCHEME—For dogs that have received their GCDS Bronze Award Certificate or above.

NOT FOR COMPETITION—Not For Competition entries will be accepted from any breed for any day of the Show. Entries to be made prior to the closing date for entries to the show. Regulation F.1.c. Only dogs of six calendar months of age and over on the first day of the show are eligible for exhibition at Kennel Club licensed shows.






