DIRECTIONS

TRAVELLING BY ROAD FROM THE SOUTH: Leave the M6 at Junction 32 (Broughton, Preston), the junction incorporates the M6 and M55 motorways and the A6 trunk road. Care should be taken to filter left following the 'A6 Garstang' lane indicators. On joining the A6, follow the 'Garstang' signs for 3¾ miles to a large sign on the left hand side of the road naming 'Myerscough College', (The show is clearly sign posted from this point) turn left along St Michaels Road, continue along this road for approx 2 miles then turn into Pinfold Lane.

TRAVELLING BY ROAD FROM THE NORTH: Leave the M6 at Junction 33 (Hampson Green). On joining the A6 travel south following 'Preston' signs for about 9 miles to a large sign on the left hand side of the road, naming 'Myerscough College', and turn right into St Michaels Road. continue along this road for approx 2 miles then turn into Pinfold Lane.

Bob Blackley (Vaevictis)

I first started showing Staffordshire Bull Terrier's in 1985 and first became active at Merseyside Staffordshire Bull Terrier Club and it's Handling Class. In 1988 I was voted on to the Committee, and progressed to Show Manager and Show Secretary, and I am now the President and Honorary Life Vice-President.

I have always been interested in all Terriers, and I started judging Staffordshire Bull Terriers in 1989, this will be my 12th CC appointment for Stafford's in the UK, I have been involved with other Terrier Breeds and I am now passed by the Kennel Club to award CC's in 19 Terrier Breeds and the Terrier Group.

I am honoured to Judge Stafford's and will give an honest unbiased opinion.



Helen Reaney (Rolenska)

I have owned Staffords since 1989 but only starting showing in May 1994, my first judging appointment was in 1996 having judged 16 open shows and five Staffordshire Bull Terrier Breed Club Shows as part of my apprenticeship. I was passed to award CC's in 2007 and have judged six General Championships shows dogs and bitches.

My first show bitch was Valglo Pacquesa, one of the top puppies during 1994. she attained her stud book number and continued to do well at all levels and was one of the top winning veterans, she produced two litters each one had one puppy, many will remember Reina Danzante she attained 2 CC's and 2 RCC's, and Rolenska Abba Ca Dabra, she produced two litters. Other notable dogs and bitches are:

Rolenska Abba Ca Dabra – consistently placed at all levels until she produced, Rolenska Take a Chance on Me – attained 1 RCC, Rolenska Here Comes Trouble – he went to France and sired 14 International Champions, Saxanjax Head Over Heels of Rolenska – placed at all levels until she produced stud book, Rolenska Leading Lady of Saxanjax – 1 RCC, Fr CH Rolenska Winner Takes It All – Champion Working & Trials, Rolenska Voulez Vous (Gimme) – placed at all levels in France, Estoy Sondando de la Vauxoise Fr Imp (daughter of CH Rolenska Winner Takes It All) – stud book, Waystaff Super Trouper At Rolenska – gained 1 RCC and Rolenska Kisses of Fire.

I only ever have a litter if I wish to keep a puppy so in my showing career I have bred eight litters.

I love nothing more than serving on Committees, I have a passion for Admin and organisation so it comes as no surprise that I have served on several committees since 1996 and still do so today.

Currently my roles include:

SBT Breed Council since 2008 as PRO and KCBL and Secretary since 2010, Notts & Derby SBTC since 2007 taking on the role of Show Secretary in 2008, then doing both the Show Secretary and Show Secretary role from 2009 up until 2019 when I now just do the Secretary role, Breed Education Co Ordinator for the Staffordshire Bull Terrier since 2018, Staffordshire Bull Terrier Club as Treasurer since 2015.

I have also been a speaker and compiled a booklet on the breed and run seminars to date:

January 2015 breed specific and hands on assessment at the Terrier Group JDP run by the Kennel Club, October 2016 breed specific seminar for the Swedish SBTC in Gothenburg, February 2017 breed specific seminar for the Swedish SBTC in Stockholm, August 2018 breed specific seminar for the Queensland SBTC in Australia and given two short seminars in New Zealand the same year, November 2019 breed specific seminar for the Russian SBTC in Moscow.

I have had the great pleasure to judge all over the world. Australia, New Zealand, South Africa, USA, Norway, Sweden, France, Spain, Poland, Czech Republic and Russia

I look forward to judging my 7th championship show but my first Breed Club Championship Show and thank the Club for inviting me whereby I will give my fair and unbiased opinion on the Bitches entered at the show. One thing that I always say to anyone is – You enter the show with the best dog and you take home the best dog.

REGULATIONS FOR THE PREPARATION OF DOGS FOR EXHIBITION F(B)

- These Regulations must be observed when a dog is prepared for exhibition and/or exhibited at any Kennel Club Licensed event. Objections may be referred to the General Committee for disciplinary action under these Show Regulations and/or for disciplinary action under Kennel Club Rule A42.
 - (a) A dog found to have been exhibited in breach of these Regulations will automatically be disqualified from exhibition at the show and from any award gained thereat.
 - (b) Unless the exhibitor provides a satisfactory explanation for the dog being exhibited in breach of these Regulations then he/she may be subject to further penalties of either a fine or as listed under Rule A42
- (a) No substance which alters the natural colour, texture or body of the coat may be present in the dog's
 coat for any purpose at any time during the show. No substance which alters the natural colour of
 any external part of the dog may be present on the dog for any purpose at any time during the show.
 - (b) Any other substance (other than water) which may be used in the preparation of a dog for exhibition must not be allowed to remain in the coat or on any other part of the dog at the time of exhibition.
- No act or operation which alters the natural conformation of a dog or any part thereof may be performed except:-
 - (a) Operations certified to the satisfaction of the General Committee.
 - (b) The removal of dewclaws of any breed.
 - (c) Operations to prevent breeding provided that such operations are notified to the Kennel Club before neutered dogs are shown.

Nor must anything be done calculated in the opinion of the General Committee to deceive.

- 4. The General Committee without previous notice may order an examination of any dog at any Show. Any examination thus ordered will be made by a person having executive authority who shall have a written directive from the Kennel Club in their possession. Samples may be taken for further examination and analysis.
- 5. An individual has the right to lodge an objection to a dog only if he/she is the owner or handler of a dog competing in the same breed or class. An objection may however, be lodged by an official of the Show or by anyone so deputed by the Kennel Club. It will be the responsibility of the individual who lodges the objection or the official (as appropriate) to substantiate the grounds for the objection. The Kennel Club will substantiate the grounds for an objection made on its behalf.
- Any objection by an individual related to an infringement of these Regulations must be made in writing to the Show Secretary at his/her office before the close of the Show and the individual must produce evidence of identity at the time of lodging the complaint.

- 17. Anyone whose dog is entered at a Kennel Club licensed event should take all reasonable steps to ensure the needs of their dog(s) are met, and should not put a dog's health and welfare at risk by any action, default, omission or otherwise. Breach of Kennel Club Regulations in this respect may be referred to the Board for disciplinary action under the Kennel Club Rules and Regulations. The use of pinch collars, electronic shock collars, or prong collars, is not permitted at any show licensed by the Kennel Club. This shall apply at the venue or within the precincts of the show.
- 18. Not For Competition. Not for Competition entries will be accepted. Details of each dog so entered must be recorded on the entry form and must be Kennel Club registered. Regulation F.1.c: Only dogs of six calendar months of age and over on the first day of the show are eligible for exhibition at Kennel Club licensed shows. However societies may accept Not for Competition entries at their discretion and dogs aged four calendar months and over are eligible to enter Not for Competition at all Kennel Club licensed shows. Furthermore, dogs aged four calendar months and over are eligible for Match Competitions.
- 19. No modifications will be made to the schedule except by permission of the Board of the Kennel Club, which will be followed by advertisement in the Canine Press wherever possible.
- 20. Overseas Exhibits. All dogs resident outside of the UK must be issued with a Kennel Club Authority to Compete number before entry to the show/event can be made. All overseas entries without an Authority to Compete number will be returned to the exhibitor/competitor.
- 21. All entries must be made on or before the closing date for entries (Postmark) upon the entry forms enclosed for that purpose. All entry forms must be accompanied by the appropriate entry fees or the entry will not be accepted.
- 22. If acknowledgement of entry is required a SAE should be enclosed.
- 23. Should a judge be prevented from fulfilling his/her engagement the Committee reserves to itself the right of appointing another judge to fulfill the duty. Exhibitors are at liberty to withdraw from the competition but no entry fees can be refunded.
- 24. No animal other than an exhibit shall be brought into the precincts of a dog show during its continuance, except any dogs registered to assist the disabled, or dogs required for educational or instructional purposes or by permission of the General Committee. However, at the discrection of the show society, a dog brought to the show by a spectator may be admitted into the precincts of the dog show, with the proviso that those in charge of the dog sign a declaration confirming the dog is free from disease and that the dog will be kept under proper control at all times.
- 25. Exhibitors showing dogs are not permitted to hold any conversation with the judge during the competition, and any exhibitor who persists in addressing the judge after being requested not to do so by the ring steward, the judge or any member of the Committee may be disqualified and reported to the Kennel Club, and any prize awarded to his or her dogs may be forfeited. No person other than the exhibitor (officials excepted) will be in the ring during judging.
- 26. The Show Manager shall have the power to exclude or remove any dog which is, in his opinion, owing to disease, savage disposition or any other cause, not in a fit state for exhibition. Once a dog has been refused admission or has been removed from the show ring, owing to disease, savage disposition or any other cause, it shall not be brought into the show at any time under any circumstances, and the case must be reported to the Kennel Club within seven days.
- 27. The Committee will be most anxious for the care and safety of dogs sent for exhibition, but it must be clearly understood that the Committee will not be responsible for the enitre or partial loss or detention of or damage to a dog or dogs, or any other property whether arising from accident or any other cause whatsoever nor for any act or omission of themselves, their officers, agents, servants and others, and it is on this understanding only that entries are accepted.
- 28. The Officers and Committee of the show accept no responsibility for products advertised or sold by standholders at the show and remind exhibitors that grooming products on sale may not meet the requirements of the Regulation for the Preparation of Dogs for Exhibition.
- 29. Any owner, competitor, handler or other person in charge of a dog is required to remove as soon as possible any fouling caused by their dog(s) at any Kennel Club licensed show within the licensed venue and within the environs of that event including car and caravan parks and approaches.
- 30. The owner, exhibitor, handler or other person in charge of a dog at Kennel Club licensed events must at all times ensure that the dog is kept under proper control whilst at the licensed venue, including its environs, car and caravan parks and approaches. This Regulation apples before (at any time during the set up period at the venue), during the event and afterwards (at any time during the breakdown of the event).
- 31. A dog may be disqualified by the General Committee from any award, whether an objection has been lodged or not, if proved amongst other things to have been: a) registered or recorded as having been bred by the scheduled judge, this shall not apply to a judge appointed in an emergency; b) exhibited without payment of appropriate entry fees.
- Every exhibitor shall ensure that whilst the dog is being exhibited, its handler shall display the correct ring number.

DEFINITIONS OF CLASSES

In the following definitions, a Challenge Certificate includes any Show award that counts towards the title of Champion under the rules of any governing body recognised by the Kennel Club. Wins at Championship Shows in breed classes where Challenge Certificates are not on offer shall be counted as wins at Open Shows. In the case of a dog owned in partnership and entered in Members' classes or competing for Members' Specials each partner must at the time of entry be a member of the Society. In estimating the number of awards won, all wins up to and including the seventh day before the date of closing of **Postal** entries shall be counted when entering for any class i.e. **Friday 16th July 2021**. Wins in Variety classes do not count for entry in breed classes but when entering for Variety classes, wins in both Breed and Variety classes must be counted. A First Prize does not include a Special Prize of whatever value.

If an exhibitor reports before the judging of a class or classes that a dog has been entered which is ineligible, the exhibitor may choose one of the following options:-

- (1) Withdrawal
 - The dog may be withdrawn from competition subject to the conditions of Regulations F.(1).19.
- (2) Transfer
 - a) If a dog is ineligible for a class or classes as regards its colour, sex, weight or height the Show Secretary shall transfer it to the equivalent class or classes for the correct colour, sex, weight or height and, in the event of there being no equivalent class, Minor Puppy and Puppy excepted, to the Open class for the correct colour, sex, weight or height.
 - b) If an exhibit is entered incorrectly in a Minor Puppy class, Puppy class or Junior class, which is over age but under twelve calendar months of age, eighteen calendar months of age or twenty four calendar months of age respectively, the Show Secretary shall transfer the exhibit to the Puppy class, Junior class or Yearling class respectively for the correct colour, sex, weight or height and in the event of there being no Puppy, Junior or Yearling class to the Open class for the correct colour, sex, weight or height.
 - c) For any reason other than the above, the Show Secretary shall transfer it to the Open class for the correct colour, sex, weight or height.
 - d) If an exhibit arrives late and misses a class, even if it is the only class in which the dog is entered, the dog may not be transferred to any other class.

MINOR PUPPY For dogs of six and not exceeding nine calendar months of age on the first day of the Show.

PUPPY For dogs of six and not exceeding twelve calendar months of age on the first day of the

Show.

JUNIOR For dogs of six and not exceeding eighteen calendar months of age on the first day of the

Show

YEARLING For dogs of twelve and not exceeding twenty-four calendar months of age on the first day

of the Show.

NOVICE For dogs which have not won a Challenge Certificate/CACIB/CAC/Green Star or three or

more First Prizes at Open and Championship Shows (Minor Puppy, Special Minor Puppy,

Puppy and Special Puppy classes excepted, whether restricted or not).

GRADUATE For dogs which have not won a Challenge Certificate/CACIB/CAC/Green Star or four or

more First Prizes at Championship Shows in Graduate, Post Graduate, Minor Limit, Mid Limit, Limit and Open classes, whether restricted or not where Challenge Certificates were

offered for the breed.

POST GRADUATE For dogs which have not won a Challenge Certificate/CACIB/CAC/Green Stars or five or more First Prizes at Championship Shows in Post Graduate, Minor Limit, Mid Limit, Limit,

and Open classes, whether restricted or not where Challenge Certificates were offered for

the breed.

LIMIT For dogs which have not become show Champions under Kennel Club Regulations or under the rules of any governing body recognised by the Kennel Club or won 3 or more

CC/CACIB/CAC/Green Stars or won 7 or more First Prizes in all at Championship Shows in Limit or Open classes, confined to the breed, whether restricted or not, at Shows where

Challenge Certificates were offered for the breed.

OPEN For all dogs of the breed for which the class is provided and eligible for entry at the Show.

VETERAN For dogs of seven years and over on the first day of the Show.

NOT FOR COMPETITION

Societies may, at their discretion, accept Not For Competition entries. Societies may accept such entries from breeds of dog not included within the title of the Society and at

shows held over more than one day, such entries may be accepted from any breed.

RULES and REGULATIONS

- 1. Opening of Show. The Show will open at 9.00 am.
- Arrival of Dogs. Dogs will be received at any time but it is the exhibitor's responsibility to ensure that exhibits are available for judging when required.
- 3. Judging time. Judging will commence at 10.00 am dogs first.
- 4. Removal of Dogs. Exhibits may be removed from the Show after their judging has been completed. Exhibits may not be removed any earlier unless by written order of the Veterinary Surgon, Veterinary Practitioner or of the Show Management, then only in very exceptional and unforeseen circumstances which must be reported to the Kennel Club. The Show will close half an hour after all judging has been completed by which time dogs must be removed.
- 5. Entry Fees: Members: £10.00 first entry per dog, Non-Members: £13.00 first entry per dog. All subsequent entries with the same dog £2.00. Not For Competition £1.00 per dog. Veteran Classes are free, the entry fee will be reimbursed at the show. Catalogues £3.00 pre-paid only. Adverts (full page) £10.00. Car Park £3.00 pre-paid. Entries can be made online at www.highampress.co.uk
- 6. Prize money. There is no prize money on offer at this Show
- 7. **Refusal of Entries.** The Committee reserves to itself the right to refuse entries.
- Puppies. Puppies under six calendar months of age on the first day of the Show are not eligible for exhibition.
- 9. Mating of Bitches. The mating of bitches within the precincts of the Show is forbidden.
- 10. Best Puppy in Show.

Where a Best Puppy in Show competition is scheduled the Best Puppy in Show is a puppy which has competed and is unbeaten by any other puppy exhibited at the same show. A puppy is a dog of six and not exceeding twelve calendar months of age on the first day of the Show. Where the Best in Show is a puppy it should automatically be awarded Best Puppy in Show. Where the Reserve Best in Show is a puppy which has only been beaten by an adult dog it should also automatically be Best Puppy in Show. Consequently, selection of Best Puppy in Show must follow the selection of Best in Show.

11. Best in Show.

Best in Show must be selected from the exhibits declared Best of Sex. If a Reserve Best in Show is to be selected, the eligible dogs are those declared Best Opposite Sex and Reserve Best of Sex to the exhibit declared Best in Show.

- 12. Exhibits will not be admitted to Best in Show competition after a period of ten minutes has elapsed since the announcement that exhibits are required for judging, unless they have been unavoidably delayed by previous judging not completed on time, and then only with the special permission of the Show Management.
- 13. Exhibitors must not pick up dogs by their tails and leads when lifting them <u>nor handle a dog in a manner which causes its feet not to touch the ground when on the move</u>. This is not acceptable. Exhibitors should note that such practice would constitute harsh handling and reports of such practice will be referred to the Committee under Kennel Club Show Regulation F11.
- All exhibitors must be familiar with Kennel Club Regulation F (Annex B) Regulations for the Preparation of Dogs for Exhibition.
- 15. All dogs resident outside the UK must be issued with a Kennel Club Authority to Compete number before entry to the show/event can be made. All overseas entries without an Authority to Compete number will be returned to the exhibitor/competitor.
- 16. DOGS IN VEHICLES ON HOT DAYS Your dog is vulnerable and at risk during hot weather and the Kennel Club offers the following guidance to help guide you through the do's and don'ts travelling to and whilst at KC licensed events.
 - When travelling to a show please take a moment to consider whether the route to the show is on a busy holiday route, and leave earlier to avoid increased time in traffic jams.
 - If your vehicle is not air-conditioned seriously consider whether travelling to the show is a good idea at all.
 - The vehicle should be as fully ventilated as possible, and plenty of stops should be taken, with lots of water available to drink.
 - Ensure your dog is not sitting in full sunlight. There should be plenty of free flowing air around the dog.
 - · When at the show, never leave your dog in the vehicle.
 - Keep the dog in the shade take your own shade for example a large umbrella and always have plenty
 of water available to drink so your dog stays well hydrated.
 - Avoid your dog taking part in unnecessary exertion, or from standing in exposed sunlight for extended lengths of time. Remember, if you feel hot your dog is very likely to feel much hotter and dehydrated, and this could lead to dire results. Please look after your dog's welfare.
